## **PURPOSE OF POSITION:**

The primary objective of the position is to support and establish improved patrol planning systems and the implementation of the USAID Greening of Prey Lang Project (USAID GPL) and USAID GPL field office in Tbeng Meanchey Town in the Northern Plains Landscape, Preah Vihear Province. This role will work closely with the USAID GPL Landscape Manager, USAID GPL Conservation Technology Officers in Preah Vihear and Phnom Penh to ensure follow up and documentation of monthly SMART patrol activities in Chhaeb Wildlife Sanctuary (CWS), Preah Roka Wildlife Sanctuary, Phnom Tbeng Natural Heritage Park and Kulen Promtep Wildlife Sanctuary (KPWS). - Filing monthly patrol efforts and payment and report PDoE through landscape manager
- Make sure well coordinate with PDoE and park directors on mobile law enforcement plans and implementation
- Build capacity and provide on-the-job training on patrol techniques and planning to rangers and community members;
- Ensure timely implementation of joint patrol;
- Ensure effective and smooth implementation of annual law enforcement workplan;
- Facilitate monthly SMART meeting and PA management meeting;
- Oversee patrol payment and equipment distribution;
- Ensure effective use of conservation technology and patrolling gears with Patrol Team Leader and Community Leaders;
- Provide support to the development of a Hotline/Tipline operation with PDOE Law Enforcement Unit;
- Work closely and build capacity of PDOE Technology Officer in SMART Room;
- Perform other tasks as requested by the Landscape Manager.
